

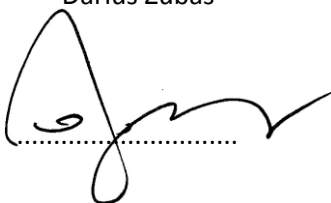
CONFIRMATION OF RESPONSIBLE PERSONS

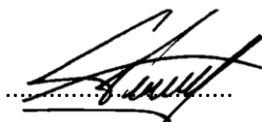
