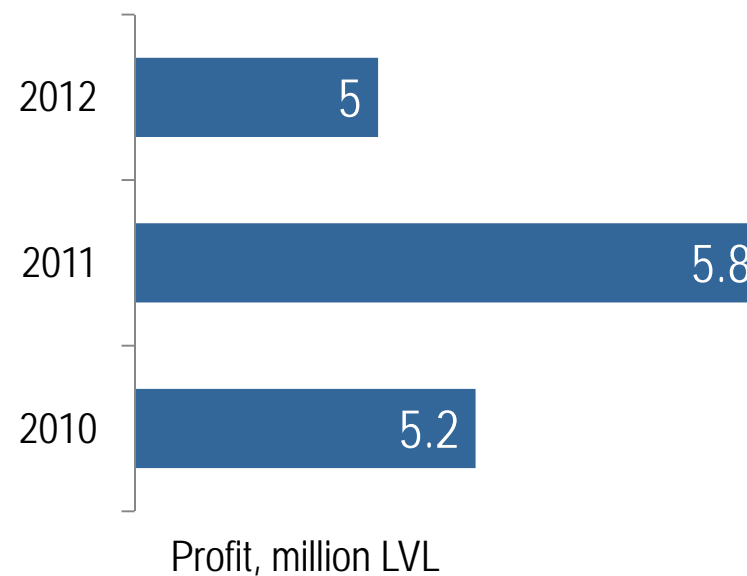
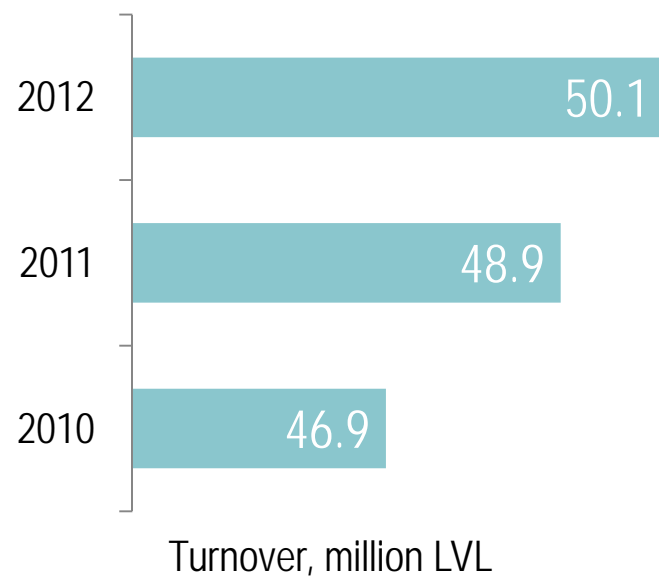


Summary of JSC “Grindeks” results for the first nine months of the year 2012



Turnover and Profit for the first nine months

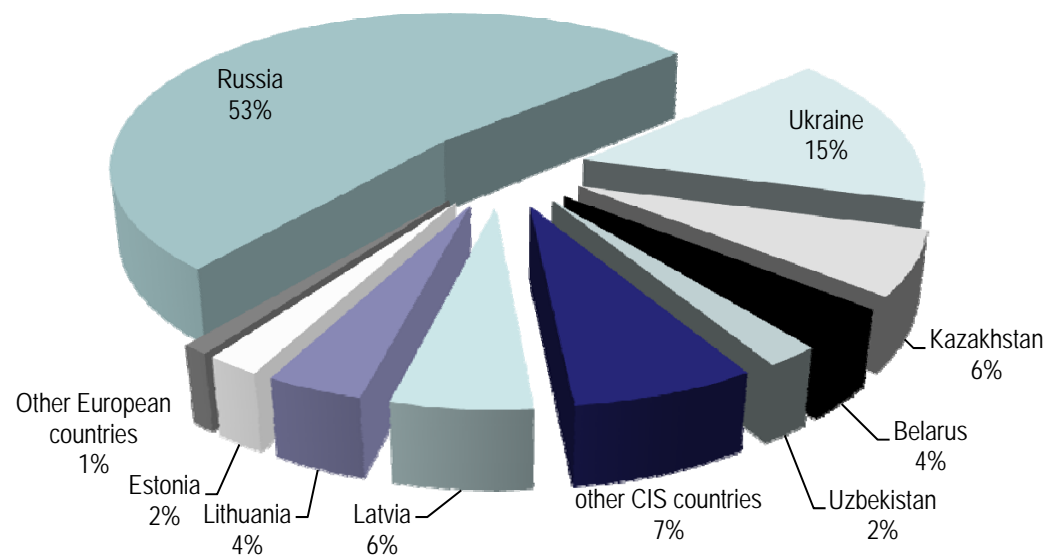


Basing on the results of the first nine months and the preliminary sales results of the first months of the fourth quarter of 2012, "Grindex", as previously reported, plans to reach at least 10% turnover and profit growth over the previous year.

Market overview

During the first nine months of 2012 the products manufactured by "Grindex" were exported to 50 countries all over the world for the total amount of 47.4 million lats.

Turnover of the final dosage forms by countries (%)



The sales volume of the final dosage forms of "Grindex" was 46.7 million lats in the first nine months of 2012 and has increased comparing to the same period of the previous year by 5 million lats or 12%.
