Cabana Trade S.A.'s holding in Componenta has decreased below 30% and Oy Högfors-Trading Ab's holding in Componenta has exceeded 10%

Componenta Corporation has received the following statement concerning a change in shareholding dated 21 September 2009 from Cabana Trade S.A. and Oy Högfors-Trading Ab, corporations where Heikki Lehtonen exercises control.

The holding of corporations where Heikki Lehtonen exercises control has changed in Componenta Corporation. Cabana Trade S.A.'s share of the total number of shares and voting rights in Componenta Corporation has decreased below 30% and Oy Högfors-Trading Ab's share of the total number of shares and voting rights in Componenta Corporation has exceeded 10%.
